Is- Sindku informa lill-membri tal- Kunsill li saret laqgħa mal- ERA rigward is- sigar tal-*ficus* tal-Pjazza. Is-Sindku qal illi ġie nfurmat li dawn is-sigar tal-Pjazza kienu qed jiehdu ħsiebhom Ambjent Malta bis-*shif*, u m'humiex fir-*remit* tal-Kunsill peress li kienu taħt kura intensiva. Din il-laqgħa ikkonkludiet illi dawn is-sigar ser jissaqqew minn Ambjent Malta darba fil- ġimgħa min naħa tagħhom, kif ukoll jissaqqew kuljum min-naħa tal-Kunsill b'metodu ta' *slow irrigation*. Il-Kunsillier Grech infurmana li tlestew x-xogħolijiet illum fi Ġnien Mitħna Qadima, u li qed nistennew li titpoġġa lura l-hamrija li kienet mixħuta fiz-żona.

2.3.7 Sistema ta' *Drip Irrigation* (Hdejn Cauchi) – Rapport ta' Hsarat

Tony il-*Handyman* infurmana li saru xi hsarat fis-sistema ta' *Drip irrigation* li tintuża biex tissaqqa Ġnejna Mustija u li tinsab hdejn Cauchi. Il-*lock* nstabet sgassata u l-ilma miftuħ. Ta' dan, sar rapport l-għassa u qed isiru l-investigazzjonijiet.

2.4 Twegibiet għall-Mistoqsijiet tal-Kunsilliera

2.4.1 Jum il-Mosta

Il-Viċi Sindku staqsta rigward Jum il-Mosta u kif ser joħorgu l-pagamenti u jithallas l-avveniment la darba m'hemmx flus minn fejn jiġu mhallsin il-kuntratturi. Is-Segretarju Eżekuttiv Templeman qalet illi legalment nistgħu nħallsu €3500 jew 5% tal-allokkazzjoni, sakemm il-Kunsill ma jaqbilx li jithallas iktar. Is-Segretarju Eżekuttiv Templeman qalet li min ser jagħmel kuntratt magħna jrid jkun lest li jithallas bit-tard peress illi l-Kunsill m'għandux minn fejn joħroġ flus. Il-Viċi Sindku semma illi jum il-Mosta tiġġenera madwar €8000 u qiegħed jitlob sabiex dawk l-fondi jintużaw għall-jum il-Mosta. Is-Segretarju Eżekuttiv Templeman semmiet li hemm fond ta' €100,000 mir-Reġjuni sabiex jintużaw mill-Kunsilli *on a first come first served basis*, u sta għall-Kunsilli biex japplikaw u jintużaw dawn il-Fondi. *Wardens*, Uffiċjali tal-Immenigjar tat-Traffiku u Enfurzar huma koperti minn dan il-Fond mingħand ir-Reġjun. Il-Viċi Sindku staqsa lill-Accountant kemm, fl-opinjoni professjonali tiegħu, jistgħu jintefqu flus fuq Gieħ il-Mosta. L-Accountant qal illi flus ma hemmx u li hemm id-dejn. Dan ifisser li l-Kunsill għandu jfittex għall-għajnuna u kwalunkwe tip ta' fondi, però għandu dejjem jonfoq l-inqas ammont possibbli. Reġa stqarr li hemm bżonn isiru l-istimi preċiżi tal- *Works Orders* pendenti sabiex wieħed ikollu stampa finanzarja ċara.

2.4.2 Kunsillier Grech – Flus biex jingabru

Il-Kunsillier Grech semma li hemm xi flejjes li għadhom ma ngabru mingħand l-Awtorita' tal-ippjanar f'isem id-*Development Planning Fund*; u li huwa sta għall-Kunsill li jingabru dawn il-flus għaliex jekk ma jingabrux jiġu li jkunu ħargu mill-Kunsill. Is-Sindku semma illi din l-problema setgħet seħħet minħabba li l-applikazzjoni biex jingabru l-flus intbġhatet jumejn tard. Il-Kunsillier Grech qal li jekk l-Awtorita' tal-ippjanar m'humix ser jaċċettaw l-emendi u jirillaxxaw l-fondi minħabba li kienet saret *change in request* fuq l-*outdoor gym* ikun minħabba li l-*claim* tkun daħlet tard. Rigward il-Proġetti tal- Outdoor Gym, ż-Żokrija u Ġnien Grognet de Vasse, għad iridu jiġu kkonfermati l-accounts mal-Accountant ta' ezattament xi tħallas u x' baqa, sabiex jingħalqu l-kontijiet u *invoices*.

19:30 Daħlet għal-laqgħa il-Kunsilliera Bonnici.

2.4.3 Tenders

2.4.5 Festa

Il-Kunsilliera Bonnici staqsiet x'inhu propost għall-festa rigward il-parkeġġ tad-diżabbilita', in-nar tal-art u għeluq fejn Ġnejna Mustija. Is-Sindku u l-Viċi Sindku stqarrew li ser jiġu segwiti l-istess pjanijiet tas-sena preċedenti. Il-Viċi Sindku semma li harġu xi kwotazzjonijiet għall-*Mobile toilets*.

2.4.6 Dog bins

Il-Kunsilliera Bonnici staqsiet rigward id-*dog bins* fejn ipproponiet sabiex ssir alterazzjoni, fejn ssir toqba żgħira li tinfetaħ biċ-ċavetta biex il-kontenturi isiru iktar effettivi billi ma jintefax skart iehor u jnaqqsu l-ħmieġ fiż-żona u waqt li jiġu mbattla. Is-Sindku qal illi problema rekurrenti f'dawn iż-żoni li qed ikun hemm boroż ta'tipijiet ta'skart iehor, li mhumiex kkonċernati mad-*dog bins*.

2.4.7 Tindif

Il-Kunsilliera Bonnici stqarret illi l-Kunsill irċieva email mingħand tal-*Cleansing* li jsir b'xejn waqt il-Festa, u jekk l-Kunsill għamilx applikazzjoni għal din l-iskema. Il-Kunsillier Zerafa għandu jiċċekkja f'dan r-rigward u jibgħat l-iskeda tal-festa sabiex nibbenefikaw minn din l-iskema.

2.4.8 Animal Welfare

Il-Kunsilliera Bonnici informat illi ser tibda tagħmel revizjonijiet lil-lista t' *Animal Welfare Officers* sabiex jitkompla x-xogħol li qed isir fir-rigward tal-*animal neutering*, flimkien mal-Animal Welfare Officer tal-Kunsill.

2.4.9 *Central strips* tal-Pjazza u Ġnejna Mustija

Il-Kunsillier Grech staqsa b'mod ġenerali għandux isir xi forma ta' *fencing* biex in-nies ma jgħaffgux il-fjuri u ħamrija. Is-Sindku enfasiżza illi ma hemmx fondi biex dan isir u kien kkonfermat mis-Segretarju Eżekuttiv Templeman.

2.4.10 Culverts

Il-Kunsillier Grech staqsa rigward t-tindif tal-*culverts*. Teżisti lista li għandu s-Sindku, fejn hemm il-*culverts* kollha mnizzlin u rrekordjati. Ser isir *follow up* f-dan r-rigward. Il-Kunsill irid jinforma lill-Gvern ċentrali biex isir dan it-tindif tal-*culverts* fit-toroq li m'humiex fir-remit tal-

Kunsill. Il-Kunsill ser igib kwotazzjonijiet biex jitnaddfu il-*culverts* illi għandu dover illi jnaddaf, ġifieri dawk li jaqgħu taħt il-Kunsill.

Il-Kunsillier Grech staqsa hux il-Kunsill ser ifittex ħlasijiet mingħand il-ħwienet fiz- Żmien tal-Festa. Il-Viċi Sindku Cassar qal li l-Kunsill m'huwiex f'pożizzjoni li ma jirċevix ħlasijiet, allura ser ikun hemm ħlasijiet.

L- Accountant beda billi jgħid li hemm xi works orders għadom iridu jinħadmu għall-proġezzjoni sal-aħħar ta' Ġunju (*2nd quarter*). L- Accountant għandu bżonn din id-data sabiex jkun jista jpingi stampa ċara tal-accounts. Baqa madwar €73,000 fil-kont tal-Kunsill, li huma stimati li jkopru l-pagi tal-ħaddiema minn Lulju 2024 sa' Settembru 2024. Il – Kunsillier Grech semma li l-Kunsill qiegħed jistenna l-allokazzjoni li stmata tidhol bejn l-aħħar ta' Settembru u l-bidu t'Ottubru. Il-Kunsillier Grech talab li jsir rendikont ta' kemm hemm *Works Orders* li ħargu, u liema minnhon x-xogħol għadu ma sarx, sabiex dan jiġi kkwantifikat. Il- Vici Sindku u s-Sindku mmarkaw li jixtiequ l-kwantifikazzjoni tal-valur ta' dawn il-*Works Orders* sabiex jingħalaq is- *2nd Quarter*. Issemmiet li l-Kunsill għandu jikkunsidra li jsir *Interim Audit* sabiex ix-xogħolijiet li saru u l-istatus tal-Kunsill sal- aħħar ta' Ġunju ikunu ikkwantifikati u evalwati. Il- Kunsillier Grech ippropona sabiex il-pagamenti li hemm mit-tmiem ta' Ġunju, jiġu mgħaqqdin mat-*3rd Quarter* sabiex is-*2nd Quarter* jingħalaq. L-Accountant tal-Kunsill Daniel Galea qal li ma jistax jgħaqqad is-*2nd Quarter* mat- *3rd Quarter* minħabba li bdiet leġiżlatura ġdida.

Il- Membri tal- Kunsill qablu illi ssir sospensjoni tal-aġenda biex tiġi diskussa l-Onoreficenza ġieħ il- Mosta.

Ser joħroġu applikazzjonijiet għall Ġieħ il-Mosta, u ser joħroġ avviz u jintbagħat lill- għaqdiet Mostin b'*email*; id-*deadline* ikun l- 20 t' Awwissu. Il-laqgħa li jmiss ser jiġu evalwati l- applikazzjonijiet. Saret diskussjoni sabiex jiġi stabbilit min hu eligibbli biex jivvota, u l-Membri tal- Kunsill qablu illi l-familja estiża u *partners* ma jistgħux jipproponu jew jissekondaw qraba tagħhom. Ukoll, min ġie nominat fis-sena preċedenti, ma jistax jerga jiġi nominat fis-sena ta' wara u jkun jista jerga japplika s - sena ta' wara, jiġifieri, jaqbez sena. Ser jiġu trangati il-kriterja mingħand il-Viċi Sindku f' dan ir-rigward.

Fit- 8.30pm is Segretarju Eżekuttiv Templeman fakkret lill-membri prezenti li fadal 30 minuta sa' tmiem il-laqgħa.

Riżoluzzjoni għall-Kunsill Lokali tal-Mosta

15 ta' Lulju 2024

Fid-dawl ta' diversi opinjonijiet espressi mill-komunita Mostija u imsieħba soċjali li joperaw ġewwa l-Mosta, qed nipproponu li jiġu riveduti l-ħinijiet tal-għeluq taċ-ċentru tal-Mosta (Pjazza Rotunda u Triq il-Kungress Ewkaristiku) l-ewwel nett:

1) mid-9 sa 15 ta' Awwissu 2024, b'tali mod li l-ħinijiet il-ġodda tal-għeluq tal-pjazza jkunu dawk li jintużaw is-soltu fiċ-ċelebrazzjonijiet tal-festa ta' Santa Marija, ibbażati fuq l-bżonn li ma jxekklu l-attivitajiet ippjanati mill-Knisja u s-soċjetajiet u għaqdiet Mostin, bil-koperazzjoni sħiħa tal-pulizija u l-forzi tal-ordni.

2) Mill-ewwel weekend tal-bidu ta' Settembru (31 ta' Awwissu u 1 ta' Settembru) iċ-ċentru tal-Mosta (Pjazza Rotunda u Triq il-Kungress Ewkaristiku) ma jibqax jingħalaq kif seħħ fl-aħħar xhur u t-traffiku jibqa jithalla jgħaddi, dejjem diment li ma jkunx hemm attività komunitarja jew kummerċjali. Dan abbażi tal-fehma ta' numru kbir ta' residenti u entitajiet kummerċjali li l-għeluq kien wiehed ta' impatt negattiv fuq l-komunita u l-livell ta' għajxien tal-Mostin, kif turi Annex B. Dan it-tibdil sar mingħajr l-konsultazzjoni meħtieġa mar-residenti Mostin. Apparti minn hekk skont Annex A, l-għeluq kien wiehed mingħajr awtorizzazzjoni tal-entitajiet responsabbli u għaldaqstant kien illeġġittimu.

Dear Mayor,

Thanks for the cordial and informative meeting held yesterday in relation to Mosta Traffic Management.

May we kindly draw the following important points :

Immediate Action

Changes in Traffic Management in Mosta I/E tal-Qares (namely Triq il-Parsott, Triq il-Kappar and Triq il-Farkizzan). This should be reverted as per original traffic flows; i.e. as at May 2024. If the local council wishes to discuss any requirements in terms of safety or traffic routes, kindly feel free to revert accordingly. Note that there was no TM authorisation for these changes in traffic flows.

It was also pointed out from your end that Triq tal-Hanqa has been turned to no traffic zone during week days. There is no authorisation from TM for this change, please remove the restriction.

There was also a request from your end in relation to changing of the traffic direction of Triq San Gwann to permit flow into Triq il-Kbira and then into Triq L-Isperanza. TM has inspected the site and it results that traffic can already flow in this direction. There was no TM authorisation for the changes on this road (it seems that this has been changed twice in the past couple of months), however TM is permitting this on a temporary basis; i.e. until other flows are resolved since it understands that residents should not need to go onto the arterial road to cross from one part to another of Mosta. It was also noted that a van is permanently parked in Triq San Gwann c/w Triq il-Kbira. It is recommended that the LC instructs enforcement action for this illegal parking to be fined since the van is hindering the safe turning into Triq il-Kbira.

Mosta Square : it is to be noted that the changes in Mosta Square are not approved by TM. However, the Local Council should take immediate action to paint stop markings at the corner between Triq il-Kbira and Triq il-Kungress Ewkaristiku and on the exit from the junction from Triq il-Kuncizzjoni to Triq il-Kbira since there is real danger of a serious collision. STOP vertical signs should also be added, should it be the case that these have not been installed.

Please note that the LC should inform the Authority once that the above changes are carried out.

Other consideration on the Local Road Network :

It is to be noted that TM gathered traffic flow data in the week between the 1st June and the 8th June from site. TM has also done a comparison with 2016 data available on google maps. During our meeting, the LC informed that since the gathering of data from site, other changes have been carried out. TM has hence carried out a second site inspection and again noted the current traffic flows. The following results

The local council should not change any further flows unless authorised by TM.

From inspection, it results that a number of roads are under construction. The direction of traffic on these roads is reversed from original. These roads include

Triq ix-Xorxa

Triq Guzeppi Callus

p/o Triq Gilormu Cassar c/w Triq it-Torri

Possibly the changes in flow are of a temporary nature. Kindly ensure that these roads are reverted to the original as soon as the works are complete. If it is the case, that this temporary traffic management is not need as is, please discuss with the temporary traffic management section – TM so that the change occurs in the immediate.

TM was also informed that there has been introduction of timed parking in the main parking area next to the church. TM informed that this is not approved.

The Arterial & Distributor Network :

It is noted that there has been a drastic unauthorised change in the Flow of Triq il-Kungress Ewkaristiku which is on the arterial network. This change in flow was complemented by a change in Triq il-Kbira which is on the local network. To our knowledge, no road safety audits have been carried out. This change also resulted in the introduction of a roundabout junction in Vjal L-indipendenza c/w Triq il-Kbira and a change in the junction (removal of roundabout) in Mosta square (Triq il-Kbira c/w Triq il-Kostituzzjoni).

This change has substantially affected Vjal L-indipendenza since additional residential Mosta traffic is pouring on the arterial network without actually having the need. In fact, Transport Malta had received complaints of increased journey times to exit from L-Imliet Area and Grognet Area since residents need to queue in Vjal L-indipendenza.

To this affect, the Authority is considering that the traffic flows in Triq il-Kungress Ewkaristiku and Triq il-Kbira may need to be reverted back to their original flows. The Authority understands that design and infrastructural works are necessary (substantial in the square). Since the local council informed that this traffic management change needs to be discussed at Local Council Level, it informed that this will be done in the August monthly meeting. The Mayor also noted that these traffic management changes may require a public consultation process and that the Local Council does not have budget to carry out any necessary changes on the arterial & distributor network.

Once that the above (point 10) is settled, the changing of other roads that are related can be considered.

The Authority noted that there is not enough turning space for a bus to perform the manoeuvre from Triq il-Kungress Ewkaristiku towards Triq il-Bazilika and that it had been informed that bus gates would be installed to stop oncoming traffic and permit the bus to turn. The stopping of traffic for the bus to turn is creating additional queues. To the knowledge of the Authority this bus gate is not functional.

The timed parking in Triq il-Kostituzzjoni was also discussed. TM informed that the only timed parking approved is as listed in the Gov Gazette. The Local Council informed that there may be the need to increase the parking time, which is currently set to one hour.

TM was also informed that p/o the square is being closed on Sunday and that possibly this should be limited only to Sat eve. TM informed that it did not approve this closure, but once that the local council submits the request, this can be seen with all the other traffic management changes and decision can be taken accordingly.

Please advise should there be something that is not in agreement from your end.

Other than this we are available to discuss as appropriate.
